



MEMBERSHIP AGREEMENT

Pursuant to California Health and Safety Code § 11362.775

I, _____ hereby certify that I am a qualified patient suffering from serious medical condition(s) and have obtained a recommendation or approval from a licensed physician in the State of California to use medical cannabis (marijuana) to treat my medical condition(s). A copy of my recommendation may be attached hereto.

As a qualified medical marijuana patient under California law, I choose to associate collectively or cooperatively to cultivate marijuana for medical purposes. All members of our medical marijuana collective will contribute labor, funds, *or materials*, and *all will* receive medicine. We form this collective in accordance with California Health and Safety Code § 11362.775, which states:

"Qualified patients, persons with valid identification cards, and the designated primary caregivers of qualified patients and persons with identification cards, who associate within the State of California in order collectively or cooperatively to cultivate marijuana for medical purposes, shall not solely on the basis of that fact be Subject to state *criminal* sanctions under Section 11357, 11358, 11359, 11360, 11366, 11366.5, or 11570."

As a medical cannabis collective, pursuant to Proposition 65, we provide the following warning to our patients:

"Smoking of marijuana and marijuana-derived products will expose you and those in your immediate vicinity to marijuana smoke. Marijuana smoke is known to the State of California to cause cancer."

MEMBER CODE OF CONDUCT

As a member of Telegraph Health Center, I hereby agree to abide by the following rules:

PLEASE, NO CELL PHONE USE ALLOWED IN THE BUILDING.

- Only legally qualified patients and caregivers may register as members of Telegraph Health Center.
- All patient members must be of 18 years of age or older and have valid photo identification as well as a valid and verifiable doctor's recommendation.
- Redistribution of medicine is strictly prohibited by Telegraph Health Center. Membership will be automatically revoked if there is evidence or suspicion of such behavior.
- Patient members are not allowed to smoke or consume cannabis in or around the premises of Telegraph Health Center.
- Loitering or smoking cigarettes in or around the premises of Telegraph Health Center is not allowed and those who do so will be asked to vacate the grounds immediately.
- All members must be respectful of neighboring businesses in the vicinity.
- No dogs or pets, except service animals, will be allowed to enter the building.
- Non-patients, children and minors will not be allowed in the building.
- Use of electronic devices such as cell phones, cameras, computers, etc. is not allowed.
- Members are allowed up to two dispensary visits per day.
- Everyone, including staff, other members and any other person on the premises must be treated respectfully. Offensive or abusive behavior and / or language may result in membership termination.
- In the event of an emergency situation, please follow the instruction of Telegraph Health Center personnel as they have been adequately trained for such situations.
- No weapons allowed.
- I hereby affirm that I have read, understand and agree to the terms of Telegraph Health Center's Membership Agreement and Code of Conduct.

Failure to comply with any of the above stated membership rules may result in temporary or permanent membership termination by Telegraph Health Center.
